**FOOD VENDOR APPLICATION**

The producers of the *Stanwood Camano Arts Festivals* are in Partnership with Stanwood Chamber of Commerce to bring you Summer Arts Jam Festival to Historic Downtown Stanwood, WA. We anticipate the *Summer Arts Jam* will bring well over 13,000 visitors in 2020.

**Requirements:** Your completed application, fee, photos of both the front and back of your booth or trailer, and an attached list of foods and beverages to be sold must be submitted by April 1st, 2020. All necessary permits must be in effect and verified 40 days before the event. Late application considered with \$15 late fee.

**Liability/Insurance:** The Stanwood Camano Arts Festivals expects booth artisans and food Vendors to carry their own insurance policy in the amount of \$1,000,000. You do not need to send a copy of your policy. Stanwood Camano Arts Festivals, Stanwood Chamber of Commerce, City of Stanwood, its employees, volunteers, directors, security or insurance company are not financially liable for losses or damages of any kind. Booth artisans should make arrangements with their own insurance companies for proper coverage. Stanwood Camano Arts Festivals will not be held responsible for any theft or damage to artists work or other personal property.

### **Permits and Insurance Requirements:**

- Booths will be inspected by the Snohomish County Health Inspector on Friday, July 10th prior to the Festival's opening. The required permit for this event should be obtained 2 – 3 weeks in advance
- Applicants must also have a food handler's permit...each booth must have one person in attendance with a permit at all times. Please call the Snohomish County Health Department for complete details on obtaining the proper permits go to [www.snohd.org](http://www.snohd.org) or call (425) 339-5250. It is the responsibility of each applicant to comply with all health regulations and have the proper permits. You will not be able to open your booth without them.

Stanwood Camano Arts Festivals, Stanwood Chamber of Commerce, City of Stanwood, its employees, volunteers, directors, security or insurance company are not financially liable for losses or damages of any kind. Booth artisans should make arrangements with their own insurance companies for proper coverage. Stanwood Camano Arts Festivals will not be held responsible for any theft or damage to artists work or other personal property.

- Each booth must have a trash containers and dry chemical fire extinguisher with a minimum capacity of 5 pounds. Halon or water types are not acceptable.
- Vendors are responsible for keeping booth area clean.
- Vendors must have an adult (18 or older) present at all times.

**Food Booths & Fees** (all fees are for the full 3-day event):

- \$100.00 for a 10x10 booth
- \$200.00 for a double booth (2 – 10x10 booths)
- \$50.00 electricity hookup & usage fee, if needed.

**Electricity:** if approved, all cords shall be protected from traffic areas. All multi-plug adaptors must be UL approved. Festival organizers retain the right to restrict or deny the use of power to any exhibitor if misuses occur.
